PROVISION 2 PUBLIC RELEASE 2024-2025

Cristo Rey OKC today announced participation in a Universal Lunch Program for School Year 2024-2025. This USDA provision allows your child(ren) to participate in the school meal programs without having to pay a fee. Provision 2 gives food service professionals more time to focus on preparing nutritious meals that their students will enjoy and gives students more time to eat those meals by cutting down on time spent in the lunch line. More importantly, by offering all students a nutritious lunch at no cost, Provision 2 helps ensure more students come to class well-nourished and ready to learn.

Children need healthy meals to learn. Cristo Rey OKC offers healthy meals every school day. Lunch meals will follow the United States Department of Agriculture (USDA) guidelines for healthy school meals, so please encourage students to participate.
